

Previously Provisional Recognition has been accorded to the class **VIII (EM)** for the years from **2021-22 to 2023-24** vide Procs.L.Dis.No.987-A1/2021, dated.01.06.2021 of the Regional Joint Director of School Education, Kakinada in **Don Bosco School, Guntupalli, Ibrahimpatnam (M), NTR District**. The Correspondent has submitted the application for Recognition to the classes **VIII (EM)** in the school for the years from 2024-25 to 2029-30 through the Deputy Educational Officer, Nandigama. The District Educational Officer, NTR, Vijayawada has verified the application for Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994.

As per the instructions of the Director of School Education, AP, Amaravati vide ref. 11<sup>th</sup> cited read with the G.O.10<sup>th</sup> cited and under Rule 3(2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby grants Recognition for a period of **6 (SIX)** years i.e., for the academic years from **2024-25 to 2029-30** to the classes **VIII (EM)** without Grant-in-Aid now or in future subject to fulfillment of the following conditions in **Don Bosco School, Guntupalli, Ibrahimpatnam (M), NTR District**.


1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized Officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for recognition sufficiently in advance i.e., at least six months prior to the date of expire of recognition now accorded.
14. That the society shall provide fire safety measures in the school as per the No Objection Certificate/advise of the fire services department authorities.
15. The management is informed that no thatched roof accommodation is allowed to run the School.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.



18. The School shall follow the traffic and safety measures shall be taken for children within the school campus and also near the school premises.
  19. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments
  20. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children and also for the various health concern of their children.
  21. The school shall have first aid kit and the teachers shall be trained in first aid.
  22. That the management shall obtain and submit the structural soundness and sanitary certificate every year before reopening of the school for the academic year.
  23. That the management shall take every responsibility for the timely, safe and comfortable mobility of the School Children from the residences to School and vice versa.
  24. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
  25. That the School Van, if any should be ensured road worthy for the transportation mobility of school children.
  26. That the school van should be free from all taxes due and should be maintained with regular checks by authorized mechanics periodically / as and when required without causing any sort of dislocation for the school children opting the van facility.
  27. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the school vans if any.
  28. That the management shall insure the vehicle and safety grills be provided to all the windows of the vehicles if any without fail.
  29. That management shall ensure the accounts of the school audited by an authorized chartered accountant every year and submit.
  30. The management shall have to follow the G.O Ms.No.01 and subsequent G.Os / memos issued from time to time without any deviation.
  31. That the management shall not run any classes other than those now permitted.
  32. That the Management should maintain plantation and minimum play area should be useful for school children.
  33. The management should maintain minimum fire extinguishers equipment in the school premises.
  34. That the management shall ensure for the regular health check of the school children periodically and shall coordinate with the Medical and Health Department authorities concerned without fail.
  35. That the management shall ensure all the children studying in their school shall be brought into child info without fail.
  36. The inspecting officer shall ensure complying with all conditions by the management from time to time.
  37. The management shall provide 25% of free seats to the disadvantaged and weaker section children in their school as per Section 12(1)(C) of RTE Act, 2009 and as per the norms issued by the Government from time to time in this regard.
  38. That the institutions are permitted to be established (or upgraded) to meet the educations needs of the respective localities, shifting of the institutions from to another will not be permitted under ordinary circumstances, as a matter of routine. However, shifting of the institutions from one building to another within the same locality if within the same town/municipal limits, may be permitted when the intention is to provide better accommodation or shifting into own building is proposed. Prior permission of the Competent Authority is required for any such shifting.
  39. That the educational agency for which permission to establish an institution has been accorded shall not transfer the institution to any other educational agency.
  40. Any deviation of the norms / guidelines issued from time to time will be viewed seriously.
- If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed. Receipt of these proceedings should be acknowledged.

Previously **Don Bosco School, Guntupalli, Ibrahimpatnam Mandal, Krishna District** has been accorded opening permission vide this office Procs.Rc.No.139/A5/2019, dated:-18.12.2019 during the academic year 2020-2021 for classes Nursery to VII.

The Secretary & Correspondent has submitted the proposals through the Mandal Educational Officer, Ibrahimpatnam with a request to accord permission for Provisional Recognition with classes Nursery to VII (EM) in **Don Bosco School, Guntupalli, Ibrahimpatnam Mandal, Krishna District** during the academic years from 2020-2021 to 2029-2030.

The Mandal Educational Officer, Ibrahimpatnam has submitted the proposals vide reference 5<sup>th</sup> cited and recommended to accord Provisional Recognition in respect of “**Don Bosco School, Guntupalli, Ibrahimpatnam Mandal, Krishna District**” for Classes Nursery to VII in EM during the academic years from 2020-2021 to 2029-2030.

After careful examination of the proposals received from the society and also inspection report of the inspecting officer i.e Mandal Educational Officer, Ibrahimpatnam, the District Educational Officer, Krishna, Machilipatnam who is the competent authority in terms of Rule 3 (1) of G.O.Ms.No.1 Education, Dated.01.01.1994 for Primary/Upper Primary Schools hereby accords **Provisional Recognition** for the classes Nursery to VII during the academic years from 2020-2021 to 2029-2030 in “**Don Bosco School, Guntupalli, Ibrahimpatnam Mandal, Krishna District**” under the management of **The Guntupalli Don Bosco Society, Guntupalli, Ibrahimpatnam Mandal, Krishna District** (Regd.No:38/1985, Dt:01.02.1985) without Grant in aid now or in future and subject to fulfillment of the following conditions.

- 2) The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 3) That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 4) That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
- 5) That the results of institution shall be satisfactory every year
- 6) That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
- 7) That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 8) That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 9) That all the conditions prescribed in the G.O.Ms.No.1 Education, Dated:01.01.1994 shall be followed.



- 11) That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
- 12) That the society shall submit proposal for Provisional recognition after reopening of schools i.e., in the month of June 2020.
- 13) That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 14) The management informed that no thatched roof accommodation is allowed to run the School.
- 15) Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
- 16) Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 17) The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 18) The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
- 19) The school shall have first aid kit and the teachers shall be trained in first aid.
- 20) The Correspondent of the concerned school is hereby informed to file an affidavit before 30<sup>th</sup> of April every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
- 21) That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail to the inspecting officer.
- 22) That the management shall ensure the Accounts of the school audited by an authorized Chartered Accountant every year and submit the same to this office along with Annual Administration Report without fail.
- 23) That the management has to maintain trained teachers at all time.
- 24) The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
- 25) That the Management is informed to obtain and submit the NOC issued by the Fire Services Dept authorities concerned from time to time without any interruption to the recognition period without fail to the Inspecting officer (if required as per rules) and also instructed to maintain fire extinguishers sufficiently in the school premises.
- 26) To follow the rules and regulations prescribed in Circular Memo No. 21748/D1/97, Dt: 16.02.1998 and other orders of /Transport authority regarding maintenance of school vehicles/maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport Authorities as prescribed by the Government from time to time.
- 27) The preventive measures regarding maintenance of school vehicles/maintenance of vehicles to ensure safety of children as instructed in Procs.Rc.No.276/PS-1/2014-2, Dated.19.06.2015 of the C.S.E., AP, Hyderabad should be followed.
- 28) Take requisite steps to enlighten all the teachers in the School about the Prohibition of Corporal Punishment in Schools
- 29) Have adequate personnel to guide the movement of the children to ensure to road safety and transportation.
- 30) The Management is informed that the above conditions should be complied from time to time. If the Management fails to comply, the Orders now issued will be reviewed without notice.
